Mae'r Rheoliadau hyn yn darparu ar gyfer cynnydd o £14.50 i £15.50 yn y ffi sy'n daladwy gan ymgymrwyr am archwiliadau o'u gwaith gan awdurdodau stryd yng Nghymru o dan reoliad 3(1) o Reoliadau Gweithfeydd Stryd (Ffioedd Archwilio) 1992 (O.S. 1992/1688). Diddymir Rheoliadau Gweithfeydd Stryd (Ffioedd Archwilio) (Diwygio) 1998 (O.S. 1998/978) (a oedd yn darparu cynnydd cynharach yn y ffi) cyn belled â'u bod yn gymwys i Gymru.

These Regulations provide for an increase from £14.50 to £15.50 in the fee payable by undertakers for inspections of their work by street authorities in Wales under regulation 3 (1) of the Street Works (Inspection Fees) Regulations 1992 (S.I. 1992/1688). The Street Works (Inspection Fees) (Amendment) Regulations 1998 (S.I. 1998/978) (which provided for an earlier increase in the fee) are revoked so far as they apply to Wales.

Mae Cynulliad Cenedlaethol Cymru, trwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 75 a 104(1) o Deddf Ffyrdd Newydd a Gweithfeydd Stryd 1991<sup>(a)</sup> ac sy'n arferadwy gan Gynulliad Cenedlaethol Cymru bellach mewn perthynas â Chymru<sup>(b)</sup>, trwy hyn yn gwneud y Rheoliadau canlynol:

### **Enwi, cychwyn a chymhwyso**

1. – (1) Enw'r Rheoliadau hyn yw Rheoliadau Gweithfeydd Stryd (Ffioedd Archwilio) (Diwygio) (Cymru) 2001 a deuant i rym ar 1 Awst 2001.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru.

### **Cynnydd yn y ffi archwilio**

2. Yn rheoliad 3(1) o Reoliadau Gweithfeydd Stryd (Ffioedd Archwilio) 1992<sup>(a)</sup> amnewidir am y ffigur "£14.50" yno y ffigur "£15.50".

### **Diddymiad**

The National Assembly for Wales, in exercise of the powers conferred upon the Secretary of State by sections 75 and 104(1) of the New Roads and Street Works Act 1991<sup>(a)</sup> and which are now exercisable by it in relation to Wales<sup>(b)</sup>, hereby makes the following Regulations:

### **Citation, commencement and application**

1. – (1) These Regulations may be cited as the Street Works (Inspection Fees) (Amendment) (Wales) Regulations 2001 and they come into force on the 1 August 2001.

(2) These Regulations apply to Wales.

### **Increase in the inspection fee**

2. In regulation 3(1) of the Street Works (Inspection Fees) Regulations 1992<sup>(a)</sup> there shall be substituted for the figure of "£14.50" there the figure of "£15.50".

### **Revocation**

**3. Diddymir Rheoliadau Gweithfeydd Stryd (Ffioedd Archwilio) (Diwygio) 1998<sup>(b)</sup> cyn belled â'u bod yn gymwys i Gymru.**

**3. The Street Works (Inspection Fees) (Amendment) Regulations 1998<sup>(b)</sup> are revoked so far as they apply to Wales.**
