Education (Wales) Bill

Introduction

This document summarises the Welsh technical and legislative terminology relevant to the **Education (Wales) Bill** ('the Bill') for information to Members, before the Plenary debate on the principles of the Bill on 2 July 2013.

The Bill was introduced by Huw Lewis AM, Minister for Education and Skills, on 1 July 2013.

- unopposed appeal(s) – **apêl (apelau) diwrthwynebiad**
- voluntary-aided school – **ysgol wirfoddol a gynorthwyr**
