

## Welsh Legislative Glossary

### Further and Higher Education (Governance and Information) (Wales) Bill

#### Introduction

This document summarises the Welsh-language technical legal terms relevant to the **Further and Higher Education (Governance and Information) (Wales) Bill** ('the Bill') for information to Members.

The Bill was introduced by Leighton Andrews AM, Minister for Education and Skills, on **29 April 2013**. The Business Committee has remitted the Bill to the **Children and Young People Committee** (in relation to its further education provisions) and the **Enterprise and Business Committee** (in relation to its higher education provisions). A **Bill summary** and a **list of general Welsh legislative terms** are available separately.
