Regulated Mobile Home Sites (Wales) Bill

Introduction

This document summarises the Welsh-language technical legal terms relevant to the **Regulated Mobile Home Sites (Wales) Bill** ('the Bill') for information to Members.

It is a Member-proposed Bill introduced by Peter Black AM, who was successful in the legislative **ballot** held on 29 November 2011. He was given leave to proceed with his Bill by the Assembly on **1 February 2012**, and there was a statement on its introduction in Plenary on **7 November 2012**. The Business Committee has remitted the Bill to **the Communities, Equality and Local Government Committee**. A **Bill summary** and a **list of general Welsh legislative terms** are also available separately.
